The Department of Technical Education prepares the Technical managers/Scientist/ Engineers/Supervisors and other professionals including skilled technicians through Post Graduate /Under Graduate and diploma level institutions in the field of Engineering & Technology, Computer, IT, Management, Pharmacy Architecture, Hotel Management and Applied Arts & Crafts.

The Financial Outlay for the 12<sup>th</sup> Five year Plan (2012-17) of the Technical Education Department was approved as Rs. 150000.00 lacs and the Annual Plan for the year 2019-20 has been approved to the tune of Rs. 21946.00 lacs (including Rs. 4570.00 lacs for SCSP component and Rs. 3000.00 lacs for Capital). Now, on the basis of requirement, the Revised Plan Outlay for 2019-20 is Rs. 22200.00 lacs (including Rs. 4620.80 lacs as SCSP and Rs. 3000.00 lacs for Civil Works). The Annual Plan Budget (tentative) is proposed for 2020-21 Rs. 26574.00 lacs (including Rs. 3000.00 lacs as Capital/Civil Work).

At the time of inception of Haryana as a separate state in 1966, there were only 6 Polytechnics (Govt.-4 and Govt. Aided-2) and only Engg. College at Kurukshetra (Joint Venture of State Govt. and Govt. of India) with annual intake of 1341 approximately. There are an exponential growth in the Technical Education Institution. Now 483 number of Technical Institute is being running with the approval of AICTE and the annual intake in the institute are 81017.

Administrative Control over the Field Institutions is exercised through the Directorate of Technical Education Haryana. The Scheme strengthening of Directorate of Technical Education Haryana is a continuing. To strengthen the Directorate of Technical Education Department further, the Chairman of the State Admission and Fee Committee, 5 more posts have also been created for the assistance of the Chairman. The Chairman of the committee enjoy the facilities, which are available to a High Court Judge. The Legislature of the State of Haryana vide Act No. 18 of 2012 has enacted Haryana Private Technical Educational Institutions (Regulation of Admission and Fee) Act 2012 to provide for regulation of Admission & Fee for Technical Courses run by Private Technical Educational Institute in the State of Haryana and for matters connected hereto. The notification to this effect has been issued by the Haryana Govt. vide No. Leg. 23/2012 dated 10.09.2012.

As a result of expansion of the Department, a post of Director General Technical Education, Haryana has been created during the financial year 2010-11 which has been manned by Super time scale IAS Officer. Further, as a result of expansion of the Department, more post are proposed to be created in the Directorate.

A sum of Rs. 618.00 lacs (including Rs. 126.60 lacs as SC Component) has been proposed for the Financial Year 2020-21 for the said scheme. This is a continuing scheme.

It was felt that in the country in general, and in North India in particular, the education opportunities in the area of visual and performing arts are lacking. Hence, the State Government decides to establish world class institutes offering newer disciplines in these fields for young and aspiring students. to nurture this initiative, a unique autonomous campus has been setup for offering degree level academic programmes in Design, Film & TV, Fine Arts and Urban Planning & Architecture by the Department of Technical Education, Government of Haryana.

In the First phase undergraduate programmes are being offered and in subsequent phase, master and research programmes shall be offered. The vision is to establish these institutes as a center of excellence in their respective areas. They shall act as a catalyst for development of art & design industry, undertake research in urban planning, boost experimental & regional cinema, act as mentor to neighboring institutes and undertake faculty and management development programmes for the academia & the corporate sector. The classes of SIFA (60 seats) SID (60 seats), SIFTV (60 seats) were started from the academic session 2011-12, whereas classes of SIUPA (40 seats) started from the academic session 2012-13.

The Integrated Campus at Rohtak, has a unique interdisciplinary approach towards the field of visual & performing arts where young professionals are prepared to be a part of the ever growing demands of these fields. The campus comprises of four institutes namely State Institute of Urban Planning & Architecture (SIUPA).

The Haryana Legislature vide Act No. 24 of 2014 has up-graded the integrated campus of Govt. Technical Institute(s), Society, Rohtak comprising of four institutes namely, State Institute of Fine Arts, State Institute of Design, State Institute of Film and Television and State Institute of Urban Planning & Architecture into a leading university namely State University of Performing and Visual Art Rohtak to facilitate and permute studies and research in emerging arrears of higher education with focus on new frontiers of Design, Fin Art, Film & Television, Urban Planning & Architecture and also to achieve excellence in these connected field. The Govt. has issued a notification to this effect vide No. Leg. 30/2014 dated 01.10.2014.

A sum of Rs. 4000.00 lacs (including Rs. 800.00 lacs for SC Component) has been proposed in the Annual Plan 2020-21 for this scheme. This is a continuing scheme.

NIFT campus Panchkula is being established by Ministry of Textiles, Govt. of India. Land measuring 10.45 acre has been provided by HUDA on free hold basis in Sector 23 (Part-II) Panchkula. The layout plan & drawing for construction of NIFT Project has been prepared by the Chief Architect, Department of Architecture Haryana. The construction of the NIFT Project has been assigned to Haryana Police Housing Corporation (HPHC) as approved by the State Government. The construction work of NIFT campus Panchkula is in progress through Haryana Police Housing Corporation (HPHC) and target date of completion is 5.6.2020.

The revised financial approval amounting to Rs.133.16 crore (Rs. 94.74 for Civil works + Rs. 38.48 for M & E) obtained from Finance Department, Haryana on 02.8.2017. As per commitment of the State Government the funds for building & academic infrastructure, Machinery Equipment as well as viability gap funding for initial 4 years etc. will be provided by the State Government.

NIFT, New Delhi has accorded approval for starting 5 nos. short term courses in the temporary campus (Community Centre, Sector 23, Panchkula) of NIFT, Panchkula from the current academic session (November/ December, 2018).

It has been decided by MHRD, Govt. of India to establish Indian Institute of Information Technology (IIIT), village Kilohrad, Sonipat to redress the increasing skill challenges of the Indian IT industry and growth of the domestic IT market. The capital cost of each IIIT has been identified as Rs. 128 Crore to be contributed in the ratio of 50:35:15 by the Central Government, the State Government, and the Industry Partners respectively. HSIIDC and Hartron have been approved as Industry Partners for the project.

The Guest Classes in 3 branches namely Computer Science & Engineering, Electronics & Communication Engineering and Information Technology with intake of 30 seats in each branch were started in the premises of National Institute of Technology (NIT) Kurukshetra w.e.f academic session 2014-15.

Land measuring 49 acre 7 kanal 11 marla of Gram Panchayat Kilohrad Distt. Sonepat was transferred in favour of Technical Education Department Haryana and the lease deed of the same was executed on 03.10.2013. Now, it has been decided in the meeting held on 16.7.2018 under the Chairmanship of Chief Secretary, Haryana that the proposed land which was leased out to Technical Education Department, Haryana for establishment of IIIT Kilohard, Sonipat would be purchased by the Technical Education Department, Haryana at Collector rate/Market rate with due approval/sanction of Development & Panchayat Department, Haryana so that the same may be transferred in favour of IIIT Society Sonipat.

The construction work of boundary wall of IIIT Sonipat is progress through PWD B&R, Haryana. The construction work of IIIT campus will be taken up on the Central



Government pattern as per decision taken by the 2<sup>nd</sup> Governing Body meeting of IIIT Society Sonipat held on 01.5.2017 under the Chairmanship of the Secretary, MHRD, Govt. of India.

The Government Engineering College, Nilokheri (Karnal) is situated in Nilokheri Tehsil of Karnal District and is well connected by road and rail. It is "143" Kms from National Capital New Delhi and "107" Kms from state capital Chandigarh. It is also well connected to many nearby states like Punjab, Himachal Pradesh, Jammu and Kashmir, Delhi, Uttar Pradesh and Utrakhand.

An announcement was made by Hon’ble Chief Minister, Haryana vide code no. 10555 dated 9.8.2015 regarding establishment of Government Engineering College, Nilokheri (Karnal) in Government Mode in the campus of GBN Govt. Polytechnic, Nilokheri.

The land area measuring 14.5 acres consisting of the following constructed building / newly constructed blocks:

1. New Teaching Block (Built up area 1,64,000 sqft.)
2. Existing Boys Hostel (capacity 100 students)
3. Girls Hostel (under construction Capacity 108 students) have been earmarked/designated for Govt. Engg. College, Nilokheri.

The available building infrastructure is sufficient to establish the Govt. Engineering College at Nilokheri with minimum investment by utilizing the available resources efficiently. The campus shall comprise of building blocks for administrative support and academics which include classrooms, laboratories, drawing halls and workshop, electrical sub-stations, parking and internal roads etc

A sum of Rs. 700.00 lacs (including Rs. 140.00 lacs for SC component) has been proposed for the annual plan 2020-21in respect of the above scheme.

Major emphasis under the scheme is on skill development, popularization of appropriate technologies and providing of technical and support services to the intended targets group. The targets group under the scheme includes SC, ST, OBC, Minority, and Women Person with disabilities, economically weaker section and other disadvantaged section of the society

Under the old scheme the funds were released by Ministry of Human Resource Development (MHRD) directly to the concerned implementing institutions and the monitoring of the scheme was made by the NITTTR.
